- I will commit to attend all scheduled academies, practices, house league, and games. If for some reason I cannot attend, I will inform my coach
- I understand that the only path to greatness is through hard work and I am dedicated to putting in the time in the gym
- I understand that academics are important to success and will persevere in my classes and complete all homework assignments to the best of my ability and share my report card with my coach
- I will be 10 minute early for all practices and academies
- I will be 30 minutes early for all games
- Upon entry to the gym I will be respectful of the coach and team already on the floor by storing my bag in a safe and organized location and focus on what I need to accomplish that day
- I will wear my CYDC practice shorts, CYDC practice jersey, and a mouth guard
- I will adhere to and respect the rules of the game
- I will always exhibit good sportsmanship, self-control, and mutual respect toward fellow players, coaches, officials and fans
- I will not wear any jewelry while on the court
- I will commit to be a disciplined player
- I will commit to play with intensity
- I understand that my behavior on and off the court reflects on CYDC and I will do my best to set a good example for others through mentorship
- I will participate in team bonding, team meetings, and fundraising events
- I agree to follow all of the rules of CYDC and understand that I can be removed from my team or suspended from the club for any violation of the above rules

Code of Conduct for Parents

The essential elements of character-building and ethics in sport are embodied in the concept of sportsmanship and six core principles: trustworthiness, respect, responsibility, fairness, caring, and citizenship. The highest potential of sport is achieved when competition reflects these "Six Pillars of Character".

I therefore agree:

1. I will be a positive role model for my child and encourage sportsmanship by showing respect and courtesy, and by demonstrating positive support for all players, coaches, officials, and spectators at every game, practice, or other event
2. I will not engage in any kind of unsportsmanlike conduct such as booing and taunting, refusing to shake hands, or using profane language or gestures with any official, coach, player or parent
3. I will not encourage any behavior that would endanger the health and well-being of any athlete
4. I will teach my child to play by the rules and to resolve conflicts without resorting to hostility or violence
5. I will ensure that my child treats other players, coaches, officials, and spectators with respect regardless of race, creed, color, sex or ability
6. I will teach my child that doing one's best (hard work) is more important than winning so that my child will never feel defeated by the outcome of a game or his/her performance
7. I will never ridicule or yell at my child or other participant for making a mistake or losing a competition
8. I will emphasize skill development and practice and how this benefits my child over winning
9. I will respect the officials and their authority during games and will never question, discuss, or confront coaches at the game and will take time to speak with coaches at an agreed upon time and place
10. I will provide and expect a sporting environment for my child that is free from drugs, tobacco, and alcohol and I will refrain from their use at all sports events
11. I will refrain from coaching my child or other players during games and practices unless I am an official coach of the team
12. I will inform the coach of any physical disability or ailment that may affect the safety of my child or the safety of others



I also agree that if I fail to abide by the aforementioned rules and guidelines, I will be subject to disciplinary action that could include, but is not limited to, the following:

- Verbal warning from an official, head coach and/or head of league/club organization
- Written warning from an official, head coach and/or head of league/club organization
- Parental game suspension with written documentation of incident kept on file
- Parental season suspension
- Player suspension
- **Player expulsion from the program (no refund)**

Code of Conduct for Tournaments

To ensure responsible and respectable manner and behavior during tournaments, the following will apply to all CYDC players:

Personal Responsibilities

- Shower daily
- Keep personal belongings neat and organized
- Maintain appropriate personal hygiene
- Keep rooms clean and tidy
- Present good table manners

Rules When Travelling

- 20 minute maximum for morning showers and preparation
- All players must be in their rooms 15 minutes before curfew (curfew will vary depending on game schedule)
- All players must be showered and ready to eat at the appointed mealtime
- No foul language, yelling, screaming or disruptive behavior inside or outside of the hotel
- No running through the hotel, jumping on furniture or dangerous play inside or outside of the hotel
- No cliques. All players must try to accommodate their team mates in all activities.
- Personal time outside of the hotel must be communicated to the Chaperone or Coach
- No swimming without permission from Chaperone or Coach (pool rules will be discussed)
- Absolutely NO ATTITUDE
- One hour prior to the departure for each game, each player must:
 - be dressed in game attire
 - stretch
 - do mental preparation



Drug and/or Alcohol Use

Drug and/or alcohol use will result in expulsion from the CYDC program

Consequences for Misconduct

There is zero tolerance for breaking the rules or not complying with duties or responsibilities. Players will be warned only once. Any player that continues to act in an inappropriate way will be benched. Players benched for the third time for inappropriate behavior will forfeit their right to continue playing in the tournament and may result in expulsion from the team.

I agree to follow the rules of CYDC Tournament Conduct and understand that I can be removed from the team or suspended from the league for any violation of the above rules.

1. **I ASSUME AND ACCEPT, WITHOUT LIMITATION, ALL RISKS AND DANGERS** associated with the Player’s participation in the Activities.
2. **I ASSUME FULL RESPONSIBILITY** for understanding and following the rules and safe practices associated with the Activities and for the Player’s personal safety.
3. **I WAIVE ANY AND ALL CLAIMS** against CYDC and its agents, representatives, coaches, players and volunteers (together with CYDC collectively referred to in this document as “**CYDC PANTHERS**”) arising from or connected with, directly or indirectly, the Player’s presence at, or participation in, the Activities.
4. **I RELEASE** CYDC PANTHERS from any and all liability for any loss, damage, injury or expense that the Player or I may suffer or incur by reason of the Player’s presence at, or participation in, the Activities, due to any cause whatsoever, **INCLUDING NEGLIGENCE ON THE PART OF CYDC PANTHERS OR OTHER PARTICIPANTS OR ANYONE ELSE.**
